This definitive record sets out the essential features and characteristics of the BSc (Hons) Dental Hygiene and Therapy course. The information provided is accurate for students entering level 4 in the 2025-26 academic year<sup>5</sup>.

### Course Summary

The BSc (Hons) Dental Hygiene and Therapy course is designed to develop dental practitioners who can fully contribute to the improvement of an individual's oral health, across a diverse population; upon graduation they will be expected to work independently within dental teams to promote oral health and restore tooth function in order to maintain a healthy oral environment. They are responsible for diagnosing, assessing, preventing and treating oral diseases and have a strong focus on prevention and health promotion; they are trained to carry out a range of activities that include the management of periodontal diseases and restorations in both primary and permanent teeth, and carry out pulp treatments and extractions on primary teeth. The interventions provided by dental hygienists and dental therapists are underpinned by contemporary evidence-based literature to ensure the most appropriate care is provided.

Students will initially develop their clinical skills in our dental clinical simulation laboratory, which contain phantom heads, and also our Centre of Dental Development, which has treatment chairs. Students will put what they learn at the University into practice within our supervised primary and secondary care placements and help to provide vital oral healthcare for local communities. Students will work within a dental and wider healthcare team, alongside dentists, dental nurses and other healthcare students. Students will undertake health promotion activities within the region, as oral health is integral to overall general health with links to systemic diseases. Professionalism and the creation of appropriate behaviours is integral to being a registered dental professional, and these are continually being developed throughout the programme of study.

The BSc (Hons) Dental Hygiene and Therapy course will be accredited by the General Dental Council (GDC) following the first cohort of students completing their studies. Students graduating from this programme will be eligible to register with the GDC as both a dental hygienist and dental therapist. Graduation opportunities will include general dental practice, the community dental service, the hospital environment, research and academia.

### **Course Aims**

In providing this programme, the University and course team aim to:

- provide educational opportunities for students to acquire the knowledge, skills and behaviours that are essential for dental hygienists and dental therapists to make a vital contribution to the oral health agenda.
- utilise authentic learning in 'real world' environments, enabling our dental graduates to manage complex oral health needs and challenges by creative thinking and collaborative working.
- build opportunities to be a socially responsible citizen, advancing the promotion of oral health through education.

- ensure employability through embedding core transferrable skills from the start of the programme.
- develop a desire for lifelong learning, creating curious dental clinicians, researchers, academics and leaders for the future.
- fulfil the requirements to be eligible to register with the General Dental Council and practice as a safe, competent and confident dental hygienist and dental therapist.

### **Course Learning Outcomes**

#### Awards

On successful completion of the course, students will be awarded a BSc (Hons) Dental Hygiene and Therapy. Students who leave the course early may be eligible for a DipHE Dental Hygiene on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a CertHE Dental Studies on successful completion of 120 credits including all mandatory modules at level 4.

### **Course Delivery**

The course is delivered at Ipswich. Students studying full-time on BSc (Hons) Dental Hygiene and Therapy are likely to have approximately 270 contact hours for level 4, 204 contact hours for level 5 and 164 contact hours for level 6. The contact hours will be a mix of lectures, seminars, group work, simulated skills sessions and self-directed hours including guided learning using the online learning platform BrightSpace. Students will also be required to participate in 14 hours a week of work placement from the third block of the programme, which will be arranged by the University. A blend of both primary and secondary care environments will be used to gain clinical experience; the location of these placements will initially be in Suffolk and then extend into neighbouring counties. Students will normally be expected to undertake 25-30 hours of independent study each week but should be prepared for this to vary based on module requirements and coursework.

### **Course Assessment**

A variety of assessments will be used on the course to enable students to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be a mixture of coursework (including essays, reports, presentations, group work, a podcast, research proposal and project), and examinations and practical assessments.

### **Special Features**

At the end of the course, graduates will be eligible to register with the GDC as a hygienist and therapist and students exiting with a named DipHE will be eligible to register with the GDC as a hygienist.

### **Course Team**

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. All staff are qualified in their subjects with their own specialist knowledge to contribute and are, where appropriate, registered with the General Dental Council or their own PSRB.

### **Course Costs**

Students undertaking BSc (Hons) Dental Hygiene and Therapy will be charged tuition fees as detailed below.

BSc (Hons) Dental Hygiene and Therapy (IHRDHT/IDHTSGLE23)

Students are likely to incur other costs for travel and car parking costs to and from placements amounting to approximately £400 per year. Optional attendance at both regional and national conferences are in the region of £15-50, excluding travel and accommodation.

Students will be required to pay for their DBS check and a small ID check and processing fee; additional fees may be incurred upon a student returning from a period of intercalation. The cost of DBS checks can be found on the <u>DBS page of the University of Suffolk website</u>. Students are likely to incur other costs for learning materials such as printing, books and stationery. Students may be eligible to claim for travel and car parking costs whilst on placement; however, these are paid retrospectively.
