This definitive course record sets out the essential features and characteristics of the BA (Hons) Social Work [degree apprenticeship] course. The information provided is accurate for apprentices entering level 4 in the 2024-25 academic year⁵.

Course Summary

The BA (Hons) Social Work [degree apprenticeship] is designed to prepare apprentices for the constantly changing and challenging environment of social work and social care practice. Underpinned by a strong commitment to social justice, the programme combines a clear academic focus on the theoretical underpinnings of social work with careful attention to practice skills, knowledge, values and personal and professional development. The BA (Hons) Social Work [degree apprenticeship] is based on a model in which apprentices are employed full-time by their employers and spend part of their working week undertaking social work studies. The requirements of the Institute for Apprenticeships (IfA) is that apprentices on the BA (Hons) Social Work [degree apprenticeship] programme spend up to 20% or 6 hours of their working time in educational activities. The pattern of working for apprentices includes attending learning and teaching activities and modules, one day a week across the year in Levels 4, 5 and 6. Programme delivery involves non-integrated and integrated aspects with undergraduate students, with similar and bespoke assessments that diversify dependent upon the learner pathway. The apprenticeship model is employer funded and employers identify potential candidates to attend the BA (Hons) Social Work [degree apprenticeship] programme, with support and collaboration from UoS.

Course Aims

The following statements define what apprentices graduating from the BA (Hons) Social Work [degree apprenticeship] course will have been judged to have demonstrated in order to achieve the award.

- At the point of completion of the course, produce social work graduates who meet all six SWE (2019) Professional Standards, nine domains of the Professional Capabilities Framework (BASW 2018) at qualifying level, and who are therefore eligible to apply for professional registration as social workers with SWE.
- To deliver a coherent curriculum that is relevant to contemporary social work practice, which is evidence-informed including by up-to-date research, theory, knowledge, social work values and practice developments.
- To utilise diverse teaching, learning and assessment methods which support the
 development of competent, thoughtful and reflective practitioners, committed to
 personal and professional development with a sound ethical base, in line with: the
 Subject Benchmark Statement for Social Work (QAA, 2019); the Professional
 Standards (SWE, 2019), the Professional Capabilities Framework (BASW, 2018), the
 Institute for Apprentices Standards (2023), the curriculum guides (TCSW/Higher
 Education Academy, 2012), and the Education and Training Standards (SWE,
 2021).
- To work closely with key partners (external examiners, employers, social work
 managers and practitioners, people who use social work services, apprentices and
 other professionals) to ensure that the course is informed by their views and
 responsive to their knowledge and experiences in order to ensure the relevance of

the course for contemporary social work practice and to promote graduates' employability.

- Deliver the prescribed curriculum for the degree based upon documentation provided by Social Work England and the Quality Assurance Agency's benchmark statement for social work (QAA, 2019), the Framework for Higher Education Qualifications in England, Wales and Northern Ireland (SHEQ), SWE Professional Standards (2019) and the Professional Capabilities Framework, managed by BASW (2018). Modules are also mapped against the Knowledge Skills Statements (KSS) for children and families and adults and Institute for Apprentices (IfA, 2023).
- Provide apprentices with an opportunity to develop a broad range of practice skills, knowledge and understanding of key subject areas and acquire a clear sense of social work values.

Course Learning Outcomes

The following statements define what apprentices graduating from the BA (Hons) Social Work [degree apprenticeship] course will have been judged to have demonstrated in order to achieve the award. These statements, known as learning outcomes, have been formally approved as aligned with the generic qualification descriptor for level 6 awards as set out by the UK Quality Assurance Agency (QAA)⁶ and the Social Work England's Professional Standards mapped against the Professional Capabilities Framework.

- 1. Understanding of what the regulatory (SWE) and professional bodies require of them as qualified social workers.
- 2. Professional capability and accountability in safely undertaking social work duties, tasks and responsibilities (PS 3 and 6)
- 3. Development in a range of cognitive, analytical, critical and reflective skills so that they can utilise assessment frameworks and undertake risk assessments, recognising and responding to abuse and neglect (PS 3).
- 4. Subject-specific knowledge and understanding to inform professional practice to include application of appropriate legal frameworks (PS 3 and 4).
- 5. Practice that is based on social work principles and values as embodied in BASW's (2018) Professional Capabilities Framework and the SWE's (2019) Professional Standards (PS 1, 5 and 6).
- 6. Development of appropriate boundaries, resilience and strategies to manage challenges and change within the increasingly complex and demanding social care context to maintain fitness to practice (PS 4).
- 7. Development of a strong and positive approach to social work which emphasises the high standards and achievements that competent and capable social workers who are fit to practice can accomplish (PS 3).
- 8. Development as an effective and autonomous professional whose assessment and decision-making skills and recommendations reflect sound professional judgements within an uncertain and complex professional context (PS 2, 3, 4 and 5).

- 9. Demonstrate understanding of the impact of cultural factors, equality and diversity in practice contexts and be able to practice in an anti-discriminatory way, promoting social justice, equality and inclusion (PS 2, 3 and 6).
- 10. Have the knowledge and ability to share information within appropriate boundaries (PS 4 and 6)
- 11. Be able to effectively communicate in all areas of practice with people who use services, carers and other professionals both verbally and in written form (PS 2).

Awards

On successful completion of the course, apprentices will be awarded a BA (Hons) Social Work [degree apprenticeship]. Apprentices who leave the course early may be eligible for a BA Social Studies on successful completion of 300 credits including all mandatory modules at levels 4 and 5 and 60 credits at level 6 or a Diploma of Higher Education Social Studies on successful completion of 240 credits including all mandatory modules at levels 4 and 5, or a Certificate of Higher Education on successful completion of 120 credits including all mandatory modules at level 4.

Course Delivery

The course is delivered at Ipswich. Apprentices studying full-time on BA (Hons) Social Work [degree apprenticeship] are likely to have approximately 204 contact hours for level 4, 195 contact hours for level 5 and 130contact hours for level 6. The contact hours will be a mix of lectures, workshops, tutor groups and personal academic coach sessions. In addition, apprentices will undertake at least 200 days of supervised and assessed practice learning in a statutory setting as identified by their employer. The rotations will be arranged by the employer. Apprentices will normally be expected to undertake on average, between 5-12

hours of independent study per week, which can include Online Learning Environment (OLE) activities, reflection, project supervision, assessment writing and other Off-the-Job-Hours (OTJH) learning activities. Apprentices should be prepared for the hours of independent study to vary based on the number of days on rotation, study days assignment tasks and deadlines, guided-directed study and classroom based and on-line learning environment activities.

Course Assessment

A variety of assessments will be used on the course to enable apprentices to experience and adapt to different assessment styles. The assessment methods used will be appropriate to assess each module's intended learning outcomes. Assessment on the course overall will be mainly coursework (including essays, reports, presentations, group work, research projects and portfolios).

Special Features

The BA (Hons) Social Work [degree apprenticeship] course is approved by Social Work England and meets the requirements of the Social Worker (degree) apprenticeship standard. Social worker is a protected title, on completion of this course graduates are eligible to apply for registration with Social Work England.

End Point Assessment

All apprentices will be required to achieve 360 credits to achieve the degree. An End Point Assessment (EPA) will take place with formal ratification of the results and completion of the BA (Hons) Social Work [degree apprenticeship].

Course Team

The academic staff delivering this course are drawn from a team that includes teaching specialists and current practitioners. Staff are qualified in their subjects with their own specialist knowledge to contribute and are registered as Social Workers with SWE.

Course Costs

Apprentices undertaking BA (Hons) Social Work [degree apprenticeship] will not be charged tuition fees directly. Tuition fees will be agreed between the University and the apprentice's employer. Apprentices will be required to sign a commitment statement before starting their apprenticeship which will detail the apprentice's, employer's, and University's expectations under the apprenticeship agreement.

Apprentices are likely to incur other costs for learning materials such as printing, books and stationary and may also incur travel and car parking costs whilst on placement.
